Rules for Facility / Casual Users

Thank you for joining Pointways Pony Club as a facility / casual user. The following Rules have been written to ensure that there is recognition that this is a club and as such all members get fair use of the facilities available.

Your fee entitles a single rider and upto 2 horses to use Pointways Pony Club Facilities. If you wish to use the facilities for more than two horses you can make application to a Committee member outlining your requirements. The Committee member will come to an arrangement on a case by case basis. There will be additional Fees to cover the additional use of the club.

If you are a grazing facility user it is the clubs policy to only have one horse grazing. You may be allowed to Graze more horses by Written application to the Committee.

The gate key must not be loaned to any other person. Please lock the gate both coming into the grounds and leaving the grounds.

When using the yards please be aware of young and inexperienced riders using the same facilities. Safety is of prime importance to the committee and members of the club.

Leave your dogs at home unless you are prepared to have them on a leash and under control at all times. Please, no dogs in the yards or arenas.

Parking for trucks is at a premium, please park with consideration for other users. No trucks to be parked in front of the yards, in front of the farrier bay for obvious reasons.

Horses should be fed in the pens behind the club house, not in the yards

When using the facilities be aware that Pony Club members have priority to the arenas after 3.30pm weekdays, weekends and during school holidays.

We will provide you with a Schedule of Rallies and events and ask that those days are kept for Pony Club members. Or that your use does not involve the front grounds or parking.

Grazing for Facility Users is granted from time to time when spaces are available. Grazing numbers are under the control of the Pointways Pony Club committee.

Current and future pony club members have first priority for grazing, and the pony club reserves the right to terminate the grazing agreement with facility users according to the terms of the agreement, on a "last on, first off" basis.

Any grazing queries or concerns to be addressed to the Pointways Pony Club Grazing Manager in writing.

You may, by arrangement only, store a truck/float on the grounds. But they must be moved for events or when requested by the committee.

You are required to complete the Causal Use / Facility User forms including all and full contact details. It is critical that we have your email address.
